6. Special Reports

6.1 Academic Spotlight – Cardinal Community Academy

Ms. April Dowdy, Director, updated the Board on the construction project that is happening at CCA. They are working with Fransen Pittman and the construction should be completed on December 20th. Ms. Dowdy also noted that academically they were rated a Performance School. CCA has seen growth in Math scores the past year and is excited about that.

6.2 NV5 Owner's Representatives: 2016 Bond Projects Update

NV5 has provided a written summary of work completed since the last update. Todd McCowin gave a summary of the ongoing projects. Meadow Ridge perimeter foundation is complete. NV5 is working through some easement issues with the town. Lochbuie and Hoff have completed RTU projects. The roof is completely done at both schools. The drainage issues at both schools are fixed in the back of the building, and temporary fixes will be in place in the front of the buildings until it can be completely fixed in the spring or summer. Hudson has an elevator shaft and steel is going up. Weld Central Middle School phase I asbestos abatement will happen soon. Permits are in and so far the project is under budget. Weld Central High School track, STEM lab, and security vestibule are the next major projects. The High School is also currently under budget. The transportation site will have some environmental things looked into. After the final purchase, design desires will be gone over to see what needs to be done before the full transportation department is housed there.

8.1 2016 Bond Capital Construction Project Budgets

Project budgets have been established for each of the six school sites. Administration and Owner's Reps are comfortable with the proposed budgets at this time. Dr. Rabenhorst requested formal budget approval on each project so that the parameters for change orders are clear. With projects underway, change orders will be frequent but should fall within the total scope of a project budget. The remaining budgets (e.g., transportation facility, athletic field at Hudson) will be established later after design phases have been completed.

Director Grundy moved to approve Capital Construction Project Budgets for Hudson Elementary in the amount of \$19,274,336.24, Meadow Ridge Elementary in the amount of \$21,425,423.35, Weld Central Middle School \$5,959,679.97, Lochbuie Elementary \$3,802,944.54, Hoff Elementary \$4,258,423.73, and Weld Central High School \$3,979,129.17. 8.2 NV5 Consulting Services Agreement – Additional Services Authorization (ASA)

The District entered into an agreement with NV5 as Owner's Representatives in 2016 prior to the Bond election. NV5 has requested additional services agreement in order to be compensated for their additional scope of work. Dr. Rabenhorst negotiated time/cost with Todd McCown and recommended the additional services agreement as presented. There are a couple of outstanding projects which may require additional services depending on their completion date. The original contract was set for work through October 2018 and some of the projects will extend beyond that timeframe (Hudson ES, WWTS for Central Campus).

9. Information/Discussion

9.1 Elementary Attendance Boundaries

Dr. Rabenhorst provided information for two options. Option A would stretch the current Lochbuie boundary from Road 4 North to Road 6 and stay West of Road 37. Option B would stretch the current Lochbuie boundary from Road 4 North to Road 10 and stay west of Road 37. There is not a great difference in numbers between the two options, but Option A is preferred. Dr. Rabenhorst will work with Director Haffner to get a colored map of Option A. The image would be used for information sharing and explanation leading up to public comment during the December 13th Public Hearing on the Boundary Changes. Dr. Rabenhorst also indicated that he may create a survey that to Lochbuie & Hudson parents regarding the boundary change. Consensus on the preferred boundary option will be determined on November 8 with Board approval for the boundary change anticipated in January.

9.2 Administrative Policy J-8 (JRCA) Sharing of Student Records/Information between School District and State Agencies (1st Reading)

This policy was on the list of policies needing to be adopted after the initial CASB Policy Audit. It is a new policy and has been reviewed by the Data Specialist and Administration. Consensus was to place this on the consent agenda next month.

9.3 Administrative Policy D-35 (DIA) Online Schools and Online Programs (1st Reading) This policy was on the list of policies needing to be adopted after the initial CASB Policy Audit. It is a new policy and has been reviewed and is recommended by the Data Specialist and High School Administration. The policy documents how enrollment and attendance could be calculated for online students when it comes to October count. Consensus was to place this on the consent agenda next month.

Director Haffner noted that he had been contacted by Melissa Bigler who works for Anderson Whitney, our auditors. Melissa just wanted to survey Bryan to see how he thought things were going, financially, in Re-3J. Director Gustafson attended the CASB Legislative Conference earlier this month. She noted there was some discussion about marijuana money and why schools are taking it, when it contradicts school values. She noted that some resolutions were canned and others would be voted on at the Delegate meeting at the annual conference in December.

Director Baumgartner noted that her Little Rebels volleyball season is over and the girls did good and had fun.

Director Grundy noted that she attended the High School career fair last week. She enjoyed her time there and was excited to see students engaged in the fair. She said that the Town of Lochbuie has a ballot measure that will create a sidewalk between our schools in Lochbuie; she hopes that parents realize the impact of this ballot measure on all of our Lochbuie students. Ms. Grundy also noted that she would like to see Courts in the Community come to the high school. She currently volunteers at Ft. Lupton high school with their Mock Trial group and knows that our students could benefit from this same type program. The Re-3J Education Foundation has sent award letters out this week. This year they are offering some mini grants at the high school for students to use on projects in their woods or welding classes. There are also a couple of mini grants available for the high school social worker to use in helping students be successful. Dr. Rabenhorst noted to the Board that he learned of some upcoming changes in Town Government officials at both Hudson and Keenesburg.
